Demonstrating Our Positive Impact



The Need

13.1% of young people in Kern County fail to graduate from high school on time.

What We Do

Power Hour helps Club Members achieve academic success by providing homework help, tutoring and high yield learning activities and encouraging Members to become self-directed learners.

Our Impact

Among our teen-aged Club Members, 95% expect to graduate from high school, and 68% expect to complete some kind of post-secondary education.

The Need

4.3% of high-school youth in Kern County were suspended.

What We Do

Keystoning is the Boy & Girls Clubs Movement's most dynamic teen program. It affords teens an opportunity to gain valuable leadership and service experience.

Our Impact

64% of Club teen members vounteer in their community at least once per month.

66% of Club members had perfect attendance.





The Need

25% of children under 18, or 1 in four, in Kern County suffer from food insecurity.

What we Do

The Boys & Girls Clubs of Kern County serve as sites and sponsors for the USDA meal and snack programs, providing healthy meals to children during out of school times, while also supporting educational and enrichment programs.

Our Impact

In an effort to help curb the food insecurities in Kern County, the Boys & Girls Club served 197,414 meals in 2019 and is on pace to serve almost 700,000 meals in 2020.
